SECTION 4. HOSTEL POLICY

I hereby agree and accept the hostel policy of Texas Chicken Malaysia Sdn Bhd

1. IMPORTANT CONDITIONS

- 1.1. TCM hostel is a hostel allocated to TCM employees who have been given permission to occupy and live in the hostel.
- 1.2. Only permanent residents who have been confirmed by the management are allowed to enter the hostel. Outsiders are prohibited from entering at any time.
- 1.3. All hostels must display a list of occupant names on the living room wall for reference purposes at all times.
- 1.4. All occupants are required to comply with all hostel rules set by the TCM management.

2. PERMISSION TO BE A HOSTEL OCCUPANT

- 2.1. Before becoming a hostel resident, a person must sign a letter confirming compliance with the hostel rules.
- 2.2. Dormitory occupants must live and occupy the dormitory room provided for themselves only and are not allowed to change or assign ownership to others without
- obtaining permission from the relevant parties:
- 2.2.1. For TCM hostel residents, the relevant party is the Area Manager.
- 2.2.2. For any hostel change, it must be made through an application letter approved by the relevant party.
- 2.2.3. Hostel occupants who quit their jobs or retire from TCM or are expelled from the hostel must return the hostel keys to the relevant party and must immediately vacate the hostel.

3. PROHIBITED AREA

Female hostels are restricted areas to male occupants or visitors and vice versa.

4. PROHIBITION

- The occupant hereby acknowledges and agrees to the conditions below:
- 4.1. It is forbidden to modify all electrical installations, designs/mounts and also damage the hostel property
- 4.2. Occupants must ensure that all electrical switches, lights and fans are turned off when leaving the room
- 4.3. Residents are strictly prohibited from speaking loudly, shouting, whistling or playing music that is too loud from 12.00 am to 7.00 am
- 4.4. Residents are strictly prohibited from using indecent words
- 4.5. Gambling such as playing cards (although not involving money), drinking alcohol, drug use is strictly prohibited. Anyone caught doing so will be removed from the hostel immediately.
- 4.6. It is prohibited to store under any circumstances, dangerous weapons, explosives and any weapons prohibited by law
- 4.7. Not allowed to hang wet clothes or towels on the windows and balcony of the dormitory
- 4.8. Pets are not allowed
- 4.9. The vehicles of hostel residents must be parked in the designated parking lot
- 4.10. Not allowed to do any business in the hostel or in the hostel environment and
- 4.11. It is not allowed to engage in any unhealthy activities and disturb other residents

5. CLEANLINESS & MAINTENANCE

- 5.1. All occupants are individually responsible for ensuring that the hostel is clean and tidy at all times
- 5.2. All occupants are not allowed to leave any dirty, smelly and soaked clothes for a long time and also leave personal belongings everywhere in the room or in the bathroom.
- 5.3. All occupants are not allowed to post pictures and posters on the walls, doors and anywhere in the hostel.

6. SAFETY

- 6.1. It is the responsibility of each occupant to ensure the safety of their property and property
- 6.2. For the safety of personal belongings/belongings as well as other occupants' personal belongings/belongings, you must always ensure that the room door and main door of the hostel are locked at all times.
- 6.3. All main doors of the hostel must have wooden doors and iron gates gated
- 6.4. All locks must be in good condition and locked at all times
- 6.5. All cases such as fraud, theft and breach of trust involving injury to others, property damage and any involvement in gangsterism and damaging and destroying public property will be 'handed over to the authorities.

7. PENALTY FOR VIOLATION OF THE LAW

- 7.1. Residents who violate the above conditions and laws will be prosecuted and punished as follows:
